I hope this letter finds you in good health and fully recovered from the 2023 Holiday season.

I am writing to let you know that I plan on running in the 2024 General Election for the Currituck County Commissioners District 4 seat as an unaffiliated or petition candidate.

I need your signatures to get on the ballot as a candidate!

What is an "unaffiliated" candidate?

There are 4 recognized political parties in North Carolina (Democrat, Green, Libertarian and Republican) who have "ballot access" - i.e. they can file to run in their party's spring primary and then advance to the November General Election.

Unaffiliated voters (often called Independent) are those who choose to not register or affiliate with a specific party.

For an unaffiliated voter to run for a partisan office and have their name appear on the General Election ballot, they must meet the petition requirements set forth in the NC General Statutes.

How many signatures do you need?

The magic number is 4% of all registered voters in Currituck County. <u>That number as of December 31 was 1,060 signatures</u>.

What is the deadline for signatures?

The deadline for submitting petitions is noon on the date of the spring primary: Tuesday, March 5, 2024.

Why am I running?

My platform is very simple:

- Bring ideas to the board of commissioners to better manage residential growth while working to attract businesses to grow/diversify our commercial tax base.
- Work to make county government more citizen friendly and OPEN *public business should be conducted in public, not in closed session.*
- Work to address citizen issues on the Currituck Outer Banks access, water, recreation, meetings and other services for ALL residents;
- Work to make county government more business friendly, so that business will want to expand in / move to Currituck, diversifying our tax base, and keeping our residential taxes stable.
- Provide adequate funding for Schools; Fire/EMS/Law Enforcement; while working to find new ways to fund these services, which are all affected by unmanaged residential development

Due to the recent slow nature of USPS delivery in our area, letters are taking 7 days to reach recipients, followed by 7 days to come back to my PO Box in Maple.

Therefore, these petitions should be returned by US Mail no later than Friday, February 23rd. If you need to drop off a signed petition, you can do so at 112 Maple Rd., Maple NC. Just gve me a call or text and let me know you will be dropping off.

I'm running because I am tired of mismanaged residential development; rising property tax rates; county government which is not service oriented; and deals discussed and made behind closed doors.
